Zoning permits are applied for together with Building Permits on the Sanpete Building Department webpage.

Zoning Permit requirements:

- Zoning Application
- Site plan or plot plan, this can be hand drawn on regular paper, it needs to show:
 - Outline of the parcel or lot line boundaries.
 - Existing structures.
 - Existing easements.
 - Location of proposed structures.
 - Distances (in feet) from proposed structure to the lot lines in all four directions.
 Roads or driveways.
- Owner affidavit.
- Police, fire, and ambulance waiver.
- Letter from HOA stating their approval (if in HOA).
- City buffer zone form (if in buffer zone).
- Photo copy of septic permit (if no city sewer).
- Proof or letter of feasibility for power service (city or Rocky Mtn).
- Proof or letter of water, approved for domestic use. (city, well, or spring). ☐ Fee of \$50. (This will be added to the building permit).

The Zoning department will check:

- Taxes must be current.
- Proof of culinary water ownership (city, well, or spring).
- Flood zones.
- Wildland Urban Interface zone (WUI).
- Setbacks from property lines.
- Frontage and/or access to road.
